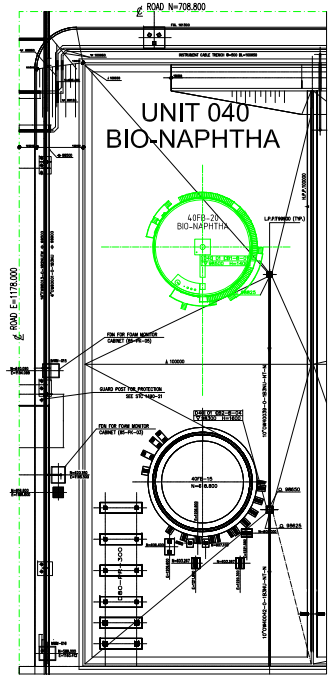
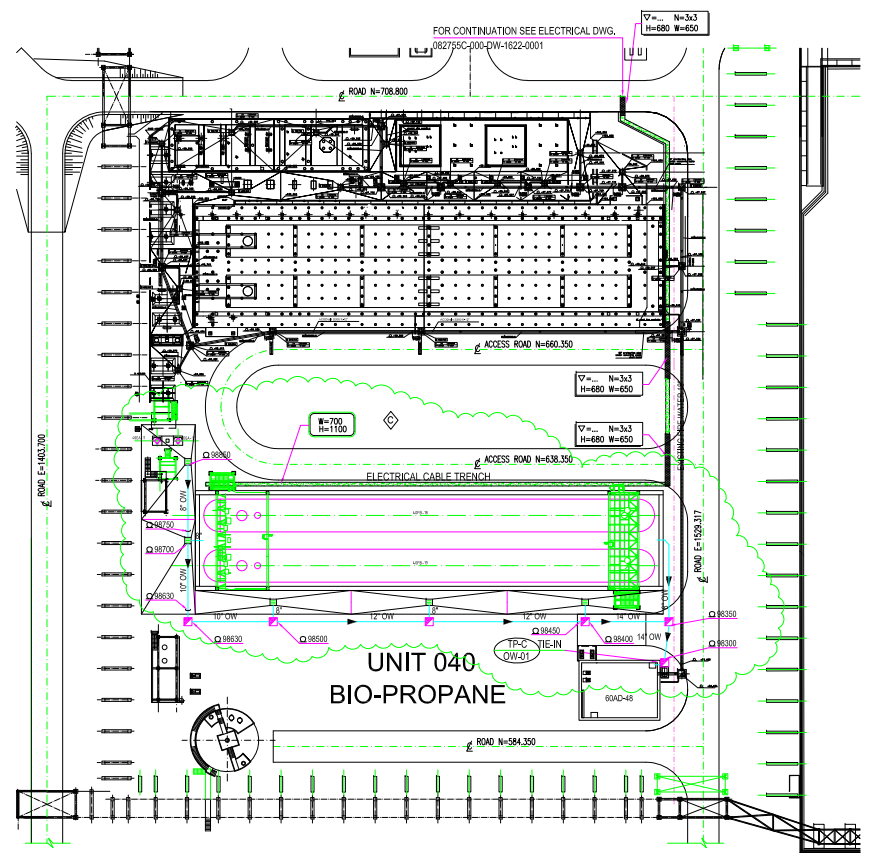
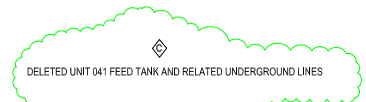

AREA 1



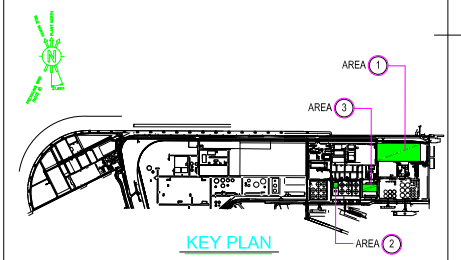

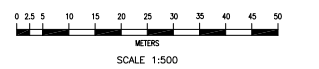
