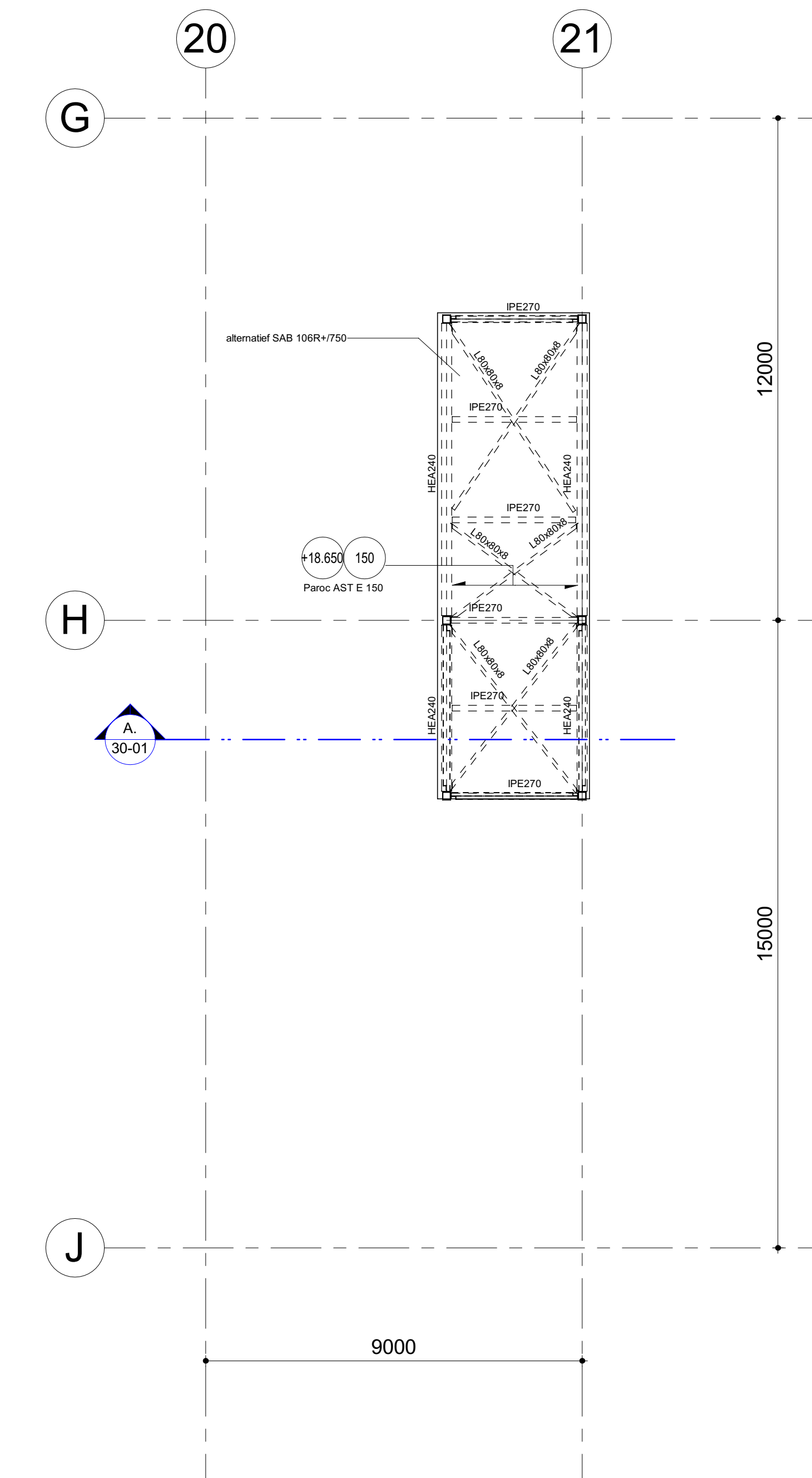
3 Dak trappenhuis as J / 2-3

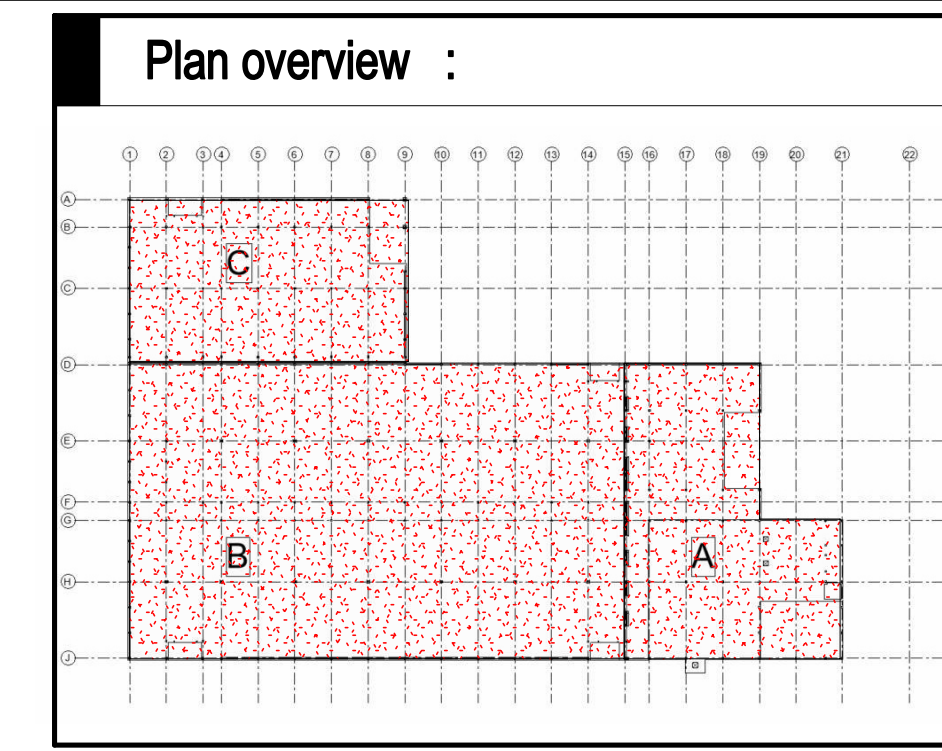

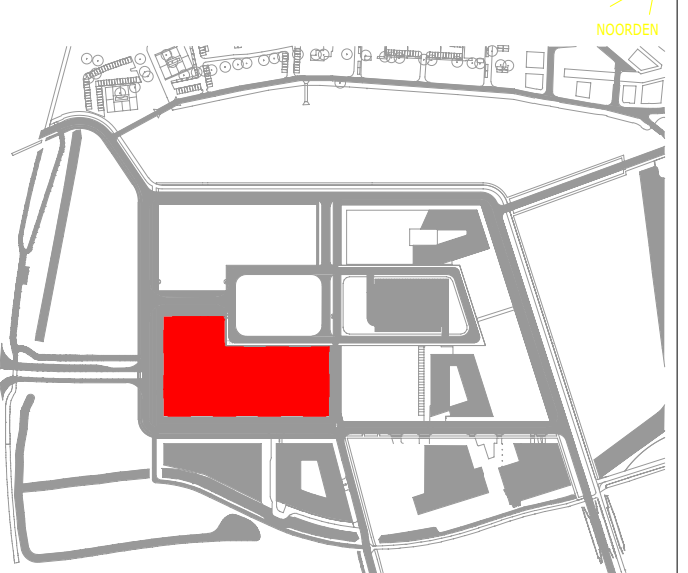
