### Werking tabel inkomstenbelasting 2018 Sint Maarten

In de tabel zijn in de eerste kolom percentages, in de tweede kolom belastbare inkomens in guldens en in de derde kolom belastingbedragen in guldens opgenomen.

Het belastingbedrag over een belastbaar inkomen wordt gevonden door het belastingbedrag uit de tabel te verhogen met de belasting over het resterende bedrag (het resterende bedrag maal het percentage).

**NB. Op de aldus berekende bedragen is de basiskorting al in mindering gebracht. Eventuele kindertoeslagen etc. moeten nog in mindering worden gebracht. De verschuldigde belasting wordt echter nooit minder dan nihil. Met ingang van 1 januari 2018 wordt geen inkomstenbelasting geheven indien het bedrag van het belastbaar inkomen gelijk is aan of minder is dan NAF 22039,68. In alle andere gevallen wordt de tabel voor het jaar 2018 normaal toegepast.**
